COMMISSION SALES AGREEMENT

§ 1

Agreement concluded on..... between.....(name and surname),

hereinafter referred to as the Consigner

and

Modessqe Sp. z o.o. with its seat at ul. Kołodziejska 18A, 30-607 Kraków, registered in the District Court for Kraków-Śródmieście, 11th Commercial Division of the National Court Register, under the KRS number: 0000460142; share capital amounting to 100.000.00 PLN fully paid up, Statistical ID No. [REGON] 122800720, Tax ID No. [NIP] 679-309-05-08  
hereinafter referred to as the Consignee.

§ 2

Consignee undertakes to take an action in order to sell works constituting property of the Consigner (or created by the Consigner) for the price agreed upon by the Parties.

§ 3

The Agreement is concluded by the Parties for a limited period of time, ending with the date 31.12.2013.

§ 4

Consignee shall sell the works only for the price agreed upon by the Parties in Annex No. 1 to this Agreement. Sale for any price outside the price limit set out in the Annex shall be forehand consulted and approved by the Consignee.

§ 5

In the event of sale transaction, the Consignee charges a commission of 50%.

§ 6

Consignee has the right to claim the commission even if the Agreement was not concluded due to the Consigner's fault.

§ 7

For as long as the Consigner does not receive the amount corresponding to the price of the sold work reduced by the Consignee's commission, the ownership shall be still entitled to the Consignee.

§ 8

All changes to the Agreement shall be made in writing, under rigor of invalidity.

§ 9

All disputes arising from this Agreement shall be subject to jurisdiction of the district court (regional court) competent with respect to the seat of the Consignee.

§ 10

The Agreement is made in two identical counterparts, one for each Party.
